FHFA House Price Index Up 0.4 Percent in April; Up 5.2 Percent from Last Year

Washington, DC – U.S. house prices rose in April, up **0.4 percent** from the previous month, according to the Federal Housing Finance Agency (FHFA) seasonally adjusted monthly House Price Index (HPI). The previously reported **0.1** percent increase for March **2019** remained unchanged.

The FHFA monthly HPI is calculated using home sales price information from mortgages sold to, or guaranteed by, Fannie Mae and Freddie Mac. From April 2018 to April 2019, house prices were up **5.2 percent**.

For the nine census divisions, seasonally adjusted monthly house price changes from March 2019 to April 2019 ranged from **-0.6 percent** in the West North Central division to **+1.2 percent** in the Mountain division. The 12-month changes were all positive, ranging from **+4.0 percent** in the Middle Atlantic division to **+7.8 percent** in the Mountain division.




Seasonally Adjusted and Unadjusted Monthly Appreciation Rates
